Attesting to her acumen in financial services, she is also Vice Chairman of FIDE Forum, whose objective is to enhance and promote high governance standards among directors of financial institutions in Malaysia.

A member of MIA and a member of the International Federation of Accountants (IFAC) Professional Accountants in Business (PAIB) Committee, Datuk Zaiton is a keen advocate for upholding codes of ethics among professional accountants, as they are instrumental in good governance and ethical behaviour.

She is passionate about giving back to the nation by supporting the accountancy profession's talent development pipelines. In 2015, Datuk Zaiton established the Malaysia Professional Accountancy Centre (MyPAC) which supports underprivileged talents to pursue professional accountancy programmes, and she is currently its Chief Executive Officer.
